Course Descriptions and Presenters

Hiring "Independent Contractors" in Washington State / Prime Contractor Liability (*All contractors*) – Learn the distinction between an "independent contractor" and an employee. This course will help you understand when you must meet safety standards, pay workers' compensation premiums, meet wage & hour requirements and pay unemployment insurance. You will also learn about potential liabilities for your Sub-Contractors Workers Compensation premiums. Presented by Allen Thurston of Labor and Industries.

Job Site Safety Set-up and Your Weeklies? (*Contractors with employees*) – Toolbox talks and jobsite inspections – a "how-to" guide for contractors. Review the basics of how to do weekly jobsite inspections and how to hold toolbox talks and the available online resources for these two activities. What has been identified as pertinent to the audit and meeting process. Learn what postings and documentation are required for your job site – for example – site safety plan, required postings, first aid and more. Green Building – What is it all about? (*All contractors*) - Learn more about Washington's green building programs and the advantages of going "green". Discover the established rating system that incorporates green building principles from start to finish. Green Building focuses on: energy efficiency; site and water considerations; indoor air quality; and materials selection to provide homes that are less expensive to own and operate, provide greater comfort, durability and are good for the environment. Effective Marketing for Contractors (*All contractors*) – Learn the differences between "marketing" and "advertising"; communication skills for the business owner; how to develop a business identity and use it effectively in advertising; and the advantages and disadvantages of the various forms of advertising. ***Plumbing Contractors – What You Need to Know** (*All contractors*) – Proof of hours, what are the employer requirements, common causes that generate an audit and what is the difference between a trainee and an apprentice. (*Experienced contractor*) - Yes, you can control and reduce your workers' compensation costs, and even get money back through the Retrospective Rating program! Learn tips and tools for your success, including hiring and training the right people for the right jobs; maintaining your accident prevention and safety plans; and appropriate and timely responses after an injury occurs. Find out about benefits, requirements and enrollment options for the Retro program. Presented Jessica Nau, Retro Program Assistant Manager.

Managing Claims to Control Your Industrial Insurance Costs (*All contractors*) – Overview of the industrial insurance claims process for the new employer. We will help you understand your rights and responsibilities to protect workers from injury and what the processes are when an employee is hurt. "Light duty" and "return to work" opportunities, communicating with and getting the proper information to the claims manager and protest timelines and information. Presented by: Gary Delozier, Claims Unit Supervisor, Labor & Industries.

Preparing Your Contract and Warranty – Learn the most important terms and conditions to have in your contract, what they mean, and why they need to be there. This course will cover warranties, scope of work, change orders, correction of work, building code issues, payment issues, commencement and completion dates, delay issues, fixed price contracts vs. T&M contracts, allowances, liquidated damages and dispute resolution. It is recommended that each attendee bring a copy of his/her company contract to review and mark up during the course. Presented by Linville Law Firm.

Managing the Difficult Customer (And Getting Paid for Your Work) – Learn how to deal with the customer who has turned out to be more difficult than you anticipated. Better yet, learn how to avoid the "lemon" customer to begin with. Learn how to create a contract that limits the potential for disputes. Learn how to manage and control both your customer and the project so that everyone is satisfied at the end of the project. Presented by Linville Law Firm.

Surviving as a Subcontractor – Learn why and how to utilize conditional bidding and inclusions, exclusions and alternates in your bidding process in order to limit your liability and provide the general contractor with expectations which are reasonable. Learn the common subcontract terms and pitfalls to avoid. The class will review problematic clauses such as pay-when-paid, change directives, warranties, pass through claims, termination for convenience, scheduling, notice, venue, and dispute resolution. Learn the basics of Washington law with the regard to the recording of liens and the filing of claims against payment bonds and retainages. Presented by Linville Law Firm.

Protecting Your Business and Your Customer – The laws of Washington afford certain protections to your customers and those laws also require that you provide certain informational notices to your customers. Learn how to protect your business through proper formation of the appropriate business entity such as a corporation or an LLC, learn who can and cannot file claims against your contractor's registration bond, and learn how to protect your customer against unwanted liens from your subcontractors and their employees. Contracting on Publicly Funded Projects (Experienced Contractors) - This seminar will provide an overview of what you need to know when contracting on a publicly owned project, including bidding, contract drafting and legal issues specific to public projects. Seth Millstein will review "must-have" clauses, discuss ways to effectively edit a general contractor's contract, and answer general questions about the contracting process. OSHA 10 and OSHA 7600 courses are offered by The Northwest Independent Contractors Association

Introduction to OSHA (WISHA) and the Culture of Safety – Learn what responsibilities Contractors have for worker safety and what rights employees have to a safety and healthy workplace. Learn how a viable and comprehensive accident prevention / safety program can save you money. Receive tools to develop or fine-tune your accident prevention program and ideas to develop a “Safety Culture” in your workplace.

Fall Protection: – Workers who work above 4’ from a platform must use fall protection and be trained on its use or implementation. Often at 10’, personal fall arrest or similar systems must be used. This class covers anchors and their requirements, personal fall arrest systems, written Fall Protection Plans (both on and off the jobsite) and covers the required training for your employees. .

Struck by – Motor Vehicle and Equipment Safety(Four Focus): This class covers common causes of struck by fatalities including motor vehicle accidents and accidents involving workers being hit by equipment while in the swing radius. Contractors will learn several techniques to having a safer jobsite when work around equipment.

Ladders, Scaffolds and Stairways: - Basic ladder, scaffold, and stairway safety requirements are covered in this class. Learn the safety regulations and best practices for their use and construction.

Caught In Between Excavation and Trenching Awareness(Four Focus): Excavation and Trenching accidents are often fatal. Knowing the basic causes of collapse, the requirements for basic trench safety, available products, and the need for a competent person can save lives at the jobsite.

Health Hazards - Heat Related Rules and Fire Extinguishers: - Heat Stress can affect all outdoor workers. This class covers Employer requirements to provide water on jobsites, signs and symptoms of heat related illness, emergency procedures for heat related emergencies, and related topics. We will also cover Fire Extinguisher training and requirements.

Electrocutions-Tool Basics/ Electrical Safety: This class covers hazards associated with construction tools, including serious injury and death. The electrical portion covers jobsite requirements for electrical safety and dangers inherent with working with electricity.

Respiratory Protection/Hazard Communication: This class is required for employers whose employees wear respirators. All employees who wear respirators must receive respirator training, medical evaluations, and fit testing. All these are provided through this program. (see Medical Evaluations/Fit Testing) Hazard Communication covers training and written plan requirements for contractors who work with chemicals such as paints, primers, epoxy’s, and glues. MSDS sheet requirements are also covered.

OSHA 7600

Introduction to Disasters Learn what responsibilities Contractors have for worker safety and what rights employees even during a Natural Disaster or Terrorist Event. Learn about potential disasters in the Pacific Northwest and what OSHA, FEMA, WA Department of Emergency Management and other agencies are doing to prepare. Learn the different descriptions and training required for Responders and workers involved in post-disaster operations.

Safety Hazards: – Workers are faced with some unique and some familiar safety hazards during a disaster response or recovery. Learn how to identify safety hazards and precautions that will protect workers. Topics covered include building safety, electrocutions, confined spaces, chainsaw hazards, falls and other hazards specific to disasters.

Preparedness, PPE, and Go-Bags: This class covers what businesses and families can do to prepare for disasters. Specifics of comfort kits or ‘go-bags’ will be discussed, as well as family plans, business plans and Personal Protective equipment that workers need will be covered.

Incident Command: - The basic concept of the National Incident Management System’s Incident Command structure will be covered in this course. Businesses will see where they fall in the structure when serving as skilled construction support to first responders.

Health Hazards in Construction: This course covers the acute and chronic health effects that could result from workers being exposed to animals, illnesses, and chemicals during disasters. Personal protective equipment and monitoring will be shown has helpful precautions to avoid health hazards. .

CBRNE: Learn about Terrorism threats such as Chemical, Biological, Radiological, Nuclear, and Explosive weapons. Workers will learn to identify potential terrorism events and what they can do to protect themselves.

Decontamination: Workers will learn the value of Decontamination for CBRNE and other health hazards caused after a disaster. Simple decontamination procedures will be discussed.

Traumatic Incident Stress Management: - Disasters inherently cause stressful conditions that can impact rescue and recovery workers. Under this program, learn to expect and manage stress by applying practical suggestions and making a plan to care for Disaster Site Workers.

Respiratory Protection: This course covers basic respirator use for Disaster Site Workers. The class covers types of respirators, their uses and limitation, cartridges and filters and proper use. STUDENTS ARE REQUIRED TO BRING THEIR OWN 3M or Similar Half Mask Respirator to the course. Fit testing and medical evaluations will be available upon request.
