Engrossed Second Substitute Senate Bill (E2SSB) 6504 (Chapter 122, Laws of 2010) reduced benefits for eligible victims of crimes under chapter 7.68 RCW. Amending WAC 296-30-900 changes and clarifies the date of eligibility in accordance with E2SSB 6504. The amendment will allow for the sunset date of July 1, 2015 provided in the legislation, to eliminate the need for further rulemaking.
