CR-101 filed last December

On December 1, 1998, L&I filed a CR-101, "Pre-proposal Statement of Inquiry" with the Washington State Code Reviser's Office. The CR-101 notifies the public that L&I is considering rule making on prevention of work-related musculoskeletal disorders. It appeared in Volume 98-24-093 of the Washington State Register.

Ergonomics Rule Making Advisory Committee begins its work

The Washington Department of Labor and Industries has convened an Ergonomics Rule Making Advisory Committee. The committee is advising L&I on the development of a proposed ergonomics rule and may suggest ways to enhance existing education, technical assistance and research efforts related to the prevention of work-related musculoskeletal disorders. The 30 members come from large and small businesses, labor and the medical community. They represent a range of industries east and west of the Cascades. (Members' names are listed below.) The advisory committee has met twice (February 23 and March 16). Additional meetings are set for April 6, April 27, May 18, June 8 and June 29.

The subcommittee will be discussing the same issues as the Ergonomics Rule Making Advisory Committee; however, the focus is limited to the construction industry. Members include construction labor and management. The advice of both the

advisory committee and the CAC subcommittee will be considered in drafting the proposed rule on ergonomics.

Employer survey, claims study provide more answers

L&I's Safety and Health Assessment and Research for Prevention (SHARP) program recently released two reports pertaining to work-related musculoskeletal disorders and ergonomics. Musculoskeletal Disorders, Risk Factors and Prevention Steps summarizes the results of a SHARP survey of Washington employers. Work-related Disorders of the Back and Upper Extremity in Washington State, 1990-1997, provides updated data on workers' compensation claims involving MSDs. OSHA releases draft regulatory text on ergonomics

The federal Occupational Safety and Health Administration (OSHA) on February 19, 1999, released draft text of a regulatory standard on ergonomics, reviving a long-stalled effort to produce a national standard. The draft is undergoing review for its impact on small business before the agency publishes a formal proposal. How will the federal effort change Washington states plans?

Michael Silverstein, M.D., assistant director for L&I's WISHA Services Division, says: "We are watching OSHA's progress closely and with great interest. But we are convinced that the best and most creative solutions for Washington state will come about right here at the state level. We don't have to wait for OSHA or develop an identical proposal to meet our legal requirement to be 'at least as effective as' an eventual federal rule."
