

Branaamijka Xuquuqul Insaanka ee L&I

Kor u qaadida helidda, Sinaata, iyo Ixtiraamka ee dhammaan macaamiisha L&I

Civil Rights Program (Branaamijka Xuquuqul Insaanka) wuxuu ku dadaala hubinta in L&I (Waaxda Shaqada iyo Warshadaha) ay hoggaansanaato sharciyda iyo xeerarka gobalka iyo federaalka ee la xiriira xuquuqul insaanka iyo takoorka lidka ku **ahasalka qaran, isirka, midabka, luuqada, jinsiga, jinsi ahaan, diinta, da'da, naafonimada**, iyo **kooxaha kale ee gaarka loo ilaaliyo**.

Iyada oo la adeegsanayo baaritaan, wax ka qabasho, iyo waxbarid dhedhexaad ah, waxaanu kor u qaadnaa heerarka ugu sareeya ee sinaanta iyo sharafta adeegyada ay bixiyaan L&I iyo adeeg bixiyeyasheeda mushaharka qaata.

L&I (Shaqada iyo Shaqaalaha) **lama** shaqayso Immigration and Naturalization Service, ma aqbalno adeeyada helitaanka luuqada, xataa iyaga oo bilaash ah, ee ay fidiyaan maamulka ciidanka laanta socdaalka ee federalku. Uma gudbin doono wax macmiilka ah macluumaadkiisa la xidhiidha laanta socdaalka dowlada federaalka ama booliska maamulka deegaanka; ujeedkeena waa inaan xaqijino in dhammaan macaamiisheena ay heli karaan dhammaan barnaamijyadeena iyo adeegyadeena.

Yaa gudbin karo dacwada takoorka?

 - Ganacsatada

Wuxaan sidoo kale aqbalnaa dacwadaha iyo soo gudbinta hay'addaha madaxabanaan.

Goormee ayaan tixgeliyaa inaan soo gudbiyo dacwada takoorka?

- Waa inaad tixgeliso inaad soo gudbiso dacwada takoorka haddii:
 - Aad codsatay – balse aad aaminsan tahay **inaadan** ka helin – adeegyo laguugu siiyo luuqada aad rabto (oo ay ku jiraan adeegyada luuqada ishaarada) mid kasta oo kamid ah shaqaale u shaqeeyya L&I ama adeeg bixiye ay L&I mushahar siiso,
iyo/ama
 - Aad aamminsan tahay in shaqaale u shaqeeyya L&I ama adeeg bixiye ay L&I mushahar siiso uu kaa reebay, uu kuu diiday inaad hesho, ama si gooni ah uu kuula dhaqmay sababo la xiriira asalkaaga qaran, isirkaaga, midabkaaga, luuqadaada, jinsiyadaada, jinsi ahaantaada, diintaada, da'daada, naafonimadaada, ama kooxo kale oo la ilaliyo aawadood.

Yaan ka gudbin karaa dacwada takoorka?

Dacwadaha takoorka waxaa laga gudbin karaa shaqaalah u shaqeeyya L&I ama adeeg bixiyeyaasha ay L&I mushahar siiso (tusaale ahaan, bixiyeyaasha caafimaadka, turjubaanada, khuburada xirfadaha).

Dacwadaha takoorka noocyadee ayay L&I aqbashaa?

- Dacwadaha takoorka ee laga soo gudbiyo loo-shaqeeyayaasha.

Fadlan la xiriir Human Rights Commission ([Guddiga Xuquuql Insaanka](#)) si aad dacwad takoort uga gudbiso loo-shaqeeyahaaga.

Waa maxay sharciyada xadidaada ee ku saabsan gudbinta dacwada takoorka?

- Wuxaan heysataa ilaa 180 maalmood laga soo bilaabo maalinta adeegyada laguu diiday iyo/ama takoorka uu dhacay si aad dacwad u gudbiso.

Haddii aanan awood u lahayn inaan baarno dacwadaada, waxaan kuu diri karnaa hay'adda habboon.

Maxaa dhacaya inta lagu jirobaaritaanka dacwada takoorka? Muddo intee la'eg ayay qaadaneyesa?

- Wuxaan ognahay inay u baahan tahay geesinimo wayn in dacwad la gudbiyo. Barnamijka Xuquuql Insaanka wuxuu ka madaxbanaan yahay barnamijiyada kale ee L&I wuxuuna qabtaabaaritaano dhameystiran oo dhexdhixaad ah.

Dacwad baaraha laguu soo xilsaaray ayaa kaa dalban doona inuu kuula kulmo fool ka fool ama taleefonka kaala hadlo si uu xog uga helo waxyaabaha dhacday.

Baaritaanada sida caadiga ah waxay qaataan ilaa iyo 90 maalmood si loo dhameystiro, balse kiisaska qaar waxay qaataan muddo intaas ka dheer si loo xaliyo.

Miyaa la iiga baahan yahay inaan foom buuxiyo haddii aan rabo inaan gudbiyo dacwada takoorka?

- Maya, foomka waa ikhtiyaar. Dacwada takoorka waxaa **toos** loogu gudbin karaa Barnaaminka Xuquuqul Insaanka iyada oo la wacayo, iimayl loo dirayo, ama toos loogu tagayo.
