





Incidence rates per 100 full-time workers for total nonfatal occupational injuries and illnesses by major industry sector, Washington , 2022 & 2023













Number of nonfatal occupational injury and illness cases with days away from work, job transfer, or restriction by private industry sector, state government, and local government, Washington, 2023



Number of nonfatal occupational injury and illness cases with days away from work, job transfer, or restriction by private industry sector, state government, and local government, Washington, 2023




