What is the SHIP Program?

The Safety and Health Investment Projects (SHIP) Grant Program funds projects that:

- Prevent workplace injuries, illnesses and fatalities.
- Reduce the cycle of disability for injured workers in Washington State.

Priority is given to proposals that encourage collaboration between employers and workers or their representatives.

The SHIP Program is required to disburse 50% of funding to safety and health projects, 25% to return-to-work projects and 25% to address the needs of small business.

See WAC 296-900-175 for rules governing the grant program.

Our Mission:

To fund and support the development of knowledge and tools to enhance the occupational safety and health of Washington workplaces;

and

To reduce the cycle of disability for injured workers by facilitating design and implementation of a return-to-work program for Washington workplaces.

SHIP Grants – General

Do I qualify?

Who is eligible for a SHIP grant?

SHIP grant projects must address the needs of employers and employees covered by the Washington State Workers’ Compensation Fund. Grant recipients may include:

- Trade associations.
- Business associations.
- Employers addressing the needs of their own employees.
- Employees and employee organizations.
- Labor unions.
- Joint labor and management groups.
- Others deemed appropriate by L&I.

Some organizations are required to have a **partner/collaborator** in order to be eligible for a grant. The partner you choose must be eligible on their own without a partner/collaborator.

How do I know if I am eligible for a grant?

There is a two-part test to determine whether you are considered an employer for SHIP grant purposes:

1. Are you an employer covered by the Washington State Department of Labor & Industries’ Workers’ Compensation Insurance?
2. Are you addressing the needs of your own employees?

If yes to both, you would be considered eligible to apply for a SHIP grant.

Organizations that represent employers or employees such as business associations, trade associations, unions, etc., are also eligible to apply provided that they are addressing the needs of those workers or businesses they represent. These organizations generally do not need a partner/collaborator to apply for a grant, but it is helpful to have letters of support.

When do I need a partner?

If you are in any of the categories below, you will need a qualified partner.

- Self-insured.
- Educational institution, unless addressing your own employee issues.
- Training organization.
- Employers who are not addressing the needs of their own employees.
- Third-party provider, such as a vocational firm or safety consultant.

All products developed as a result of a SHIP grant are in the public domain and cannot be copyrighted, patented, claimed as trade secrets or otherwise restricted in any way.

Products produced by grant projects will be accessible for download from the program website after the projects are completed.

What should I look for in a partner?

The qualified partner you choose must:

- Be eligible without a partner/ collaborator.
- Be responsible for performing significant activities under the project.
- Share in decision making.

Grants will NOT be awarded for: lobbying or political activities; legislative or regulatory initiatives; any activity not designed to reduce workplace injuries, illnesses or fatalities; or reimbursing employers for the normal costs of complying with safety and health rules.

Safety and Health Grants

Types of possible safety and health projects:

- Develop innovative ideas for solutions to omit/control workplace hazards.
- Create learning materials such as videos, training, etc., to promote safety culture in the workplace.
- Identify best practices for workplace safety and health programs.

Why apply? (Benefits)

- Improve workplace safety.
- Prevent injuries and illnesses.
- Save lives.
- Educate employers/employees on workplace safety.

Examples of safety and health grants:

Underground construction safety video

Construction protection plan in Spanish and Russian

Hospitality industry workplace safety training

Ergonomics resources for grocery workers

Green building safety awareness training

Hazard training for workers exposed to residual sewage

Return-to-Work Grants

Types of possible return-to-work projects:

- Develop and implement innovative and effective return-to-work programs for injured workers.
- Education and training.
- Other projects that assist in getting employees back to work.

Why apply? (Benefits)

- Allow a skilled/experienced employee to continue working for you.
- Keep loss of productivity to a minimum.
- Reduce cost of training a new employee.

Examples of return-to-work grants:

Strategies to increase participation in early-return-to-work programs among health-care workers

Multimedia training for supervisors of health-care workers

Return-to-work procedures and policies, including job analysis for existing positions and light duty for public works and police workers

Task assessment videos to promote appropriate return to work in specific construction trades

Online database for completing employer job description for transitional (light duty) job descriptions for provider's review

Food service industry guide to return to work
