Ten-decimal Increment Factors

For claims <u>not</u> at the minimum or maximum time loss rate:

- *There was no COLA from 7/1/11 through 6/30/12 (<u>RCW 51.32.075</u>)
- Annual COLAs resumed beginning 7/1/12, but claims with dates of injury or manifestation on or after 07/01/11 do not receive a COLA until the second July 1 (<u>RCW 51.32.075</u>)

For claims that are at either the minimum or maximum time loss rate, do not use this table. Instead use the <u>Minimum Time-Loss Rates</u> chart or the <u>Maximum Time-Loss Rates</u> chart.
