CORRESPONDENCE: Apprenticeship Program Manager, Peter Guzman presented and certified the October 1 to December 31, 2022 Correspondence Log as a true and correct summary of communications sent and received by the Department. Name

Apprenticeship Preparation & Tiny Houses – Melinda Nichols, ANEW Consultant and Frank Chopp, Washington State House Representative 43rd District (Invited) Melinda spoke about the \$1 million allocated last year by the legislature to build 50 Tiny Houses. In addition, 400 pre-apprentices, some high school and college students received \$1,300 each to build the Tiny Houses. Billy Burchett, Tulalip TERO Pre-Apprenticeship Program spoke of the great partnership with Low Income Housing Institute who supplies the materials for the Tiny Homes they made for the community and their tribe. Lawrence Willis, Director and Founder of the L.O.V.E. T.O. Pre-Apprenticeship Program added doing Tiny Houses gives young men and women stability, training, and life skills. This allows them to train great apprentices and pre-apprentices going into Apprenticeship.

Office of Superintendent of Public Instruction

Jill Diehl spoke about Superintendent Chris Reykdal's annual update on the State of Washington's K-12 students. OSPI recently visited the Regional Apprenticeship Program in Marysville through the school district and got to see the students in action.

Oregon State Apprenticeship and Training Council

State Board for Community and Technical Colleges

Genevieve Howard spoke about working with the 19 colleges who offer RSI and are participating in the "Communities of Practice" process to work on consistency of coding across the system, consistency of messaging, and looking to grow the Multi-Occupational Trades (MOT) degree option across the state as well as working on their credit equivalency policy.

U.S. DOL, Office of Apprenticeship

Washington State Apprenticeship Coordinators Association

Jeremy Clevenger reported on how informational the Pacific Northwest Apprenticeship Conference was. He also encouraged the Coordinators and Apprenticeship programs to participate in surveys sent out by the Department to get more information and data on their apprentices to help with supportive services.

Washington Student Achievement Council

Gabriele Matull Worst gave statistics regarding the Washington College Grant Program. Two Sponsors, Advanced Manufacturing Apprenticeships (AJAC) and Evergreen Rural Water of Washington (ERWoW) are participating in the program. In 2021, there were 56 apprentices who received awards; in 2022, there were 95 apprentices. 65 percent are receiving the maximum amount award of \$4,466.

Workforce Training and Education Coordinating Board

Secretary, Washington State Apprenticeship and Training Council

Celeste Monahan welcomed Rio Frame as the managagement Analyst for the Retention Study. The study was presented at the January quarterly coordinators JRRC meeting with the anticipated survey rollout to registered apprentices February 1. She also said the Apprentice grant has issued 50 award letters totaling about \$5.9 million. There are still funding opportunities available.

WSATC Childcare in the Trades Subcommittee

Shana Peschek spoke about some upcoming bills, one of which is to increase access to subsidies for childcare for first-year apprentices and raise the income level requirements. Currently you are not eligible if you make \$60,000 a year for a family of four. If successful, it would mean a co-pay of \$125 monthly. The other bill establishes a pilot project to support some near-site childcare facilities for things like the 520 project. The intent is to get childcare that would have nonstandard hours near construction sites.

Patrick Martin reported the Department shared information about an expedited rulemaking, the CR-105 process, to adjust some language with the WAC. This would align the WAC with rule and law. Rob Bartel asked the Department to host a handful of meetings that can share some information which will dispel some misinformation about Apprenticeship, and get the facts out to the public.
