Subsequently, the VBOG (Veterinary Board of Governor's) voted on December 5, 2022 to submit a CR101 to begin the rulemaking process to make registered apprenticeship an explicit pathway in the RCW for a LVT to sit for the national exam (VTNE). CVC plans to begin 2 apprentices in January 2023.

STATEWIDE VETERANS & MILITARY FAMILIES PROGRAM

For the Veterans and Military Families program:

- Attended a quarterly DOL/DOD Defense Industrial Base (DIB) Employer Roundtable with known contractors who are in the ship and submarine building. Many of these employers hire directly from apprenticeships and purpose of roundtable is to connect those employers (and apprenticeships) with LVERs and CVSRs. Washington has 7 known primary contractors in our state not counting subcontractors. LVERs and CVSRs closest to these contractors are attending these meetings.
- Program operations and several DVOP, LVER and CVSR staff across the state attend the monthly
 Washington State Military Transition and Readiness Council (WSMTRC) Community of Practice for
 Apprenticeships, including planning for how to include apprenticeship sites with direct hiring
 employers at future job fairs.
