22	So before legislation, we saw some pretty big changes
23	for plumbers. This last legislative session was contractor
24	registration with significant changes, which I wanted to
25	share with you. Some of those changes that are occurring
	Page 6

1 happen July 23rd of this month for this year. And those 2 are, for successorship for contractor registration, you can now deny a registration for contractor if the applicant is 3 called the successor to a previous business where -- what 4 that means is if I have a judgment and I no longer am 5 6 eligible to register as a contractor, I will go to my 7 brother, my sister, my mom, and have them register for me. 8 So, before, that has happened in order to obey judgments, and we don't have any way to is stop that. 9 So this 10 legislative change now let's us deny registration for 11 successorship.

12 It also requires an applicant to be 18 years of age at 13 the time of application. Right now there is no age limit to 14 be a construction contractor, or age requirement.

And then the last taking effect this month is we can
now accept an ITIN, which is an individual tax
identification number, in lieu of a Social Security number.
So this legislation is taking effect in three parts. So
this is the first part.

The second part takes effect July 2024, and it's a bond increase amount. And the bonds for general contractor are going from \$12,000 to \$30,000, and for a specialty contractor, from \$6,000 to \$15,000.

Also taking effect July of next year is penalty amount increase, and it will be a maximum \$10,000 penalty for



1 working unregistered. And that doesn't mean, all of a 2 sudden, anybody who is working out of compliance is getting a \$10,000 penalty. That's the maximum. It's going to be 3 4 used -- we're going create an escalation strategy, very strategic about how we would implement that, and it's going 5 6 to be used on the repetitive violator's egregious act. It's 7 not going to be, you know, for those first and second offenses. 8

9 The last change is taking effect July of 2026. It's a 10 homeowner recovery fund. So that will be if the bond pays 11 out, somebody else puts a claim in, gets a bond, there's no 12 bond left for them, they can then come to the Department to 13 seek reimbursement from the Homeowner Recovery Fund.

14 And this is actually going to be the first time in 15 Washington State history where a state agency is reimbursing 16 consumers. That fund is going to be funded strictly from penalty amounts. So it's going to be the underground 17 18 economy activity that is funding the account. And there's 19 some caps on it. We can't pay over \$25,000. We can't pay 20 out more than 80 percent of the account from the previous 21 balance. So there's a lot to figure out without some major 22 changes, one of the most significant legislation changes 23 I've ever seen in contractor registration.

So I just wanted to give you an update on that. I know there's -- it doesn't affect the plumbing contractors, but I Page 8

1	know there's several that also have the construction
2	contractor business as well.
3	MR. TODD ALLRED: So, point of clarification.
4	MS. MELISSA MCBRIDE: Yes.
5	MR. TODD ALLRED: On the fine escalation that you
6	were talking about, that is for construction contractors?
7	MS. MELISSA MCBRIDE: Yes.
8	MR. TODD ALLRED: So anybody that has a GC?
9	MS. MELISSA MCBRIDE: Any violations to 18.27;
10	so, yes.
11	MR. TODD ALLRED: Okay.

14	Strictly violations to the contractor registration laws.

Plumbing program activity.

That's you, Melissa.

MS. MELISSA MCBRIDE: That's me. Thank you. 3 Okay. So I believe at the last meeting I spoke about 4 how we had new -- we got a new staff on board, Bethany, who 5 6 introduced herself. It's been so great having Bethany along 7 with Alisha and Whitney. They have been working so hard. 8 There's no backlog. They are current on plumbing contractor 9 applications, affidavits, voice mails, emails, everything. 10 They are caught up, and they are staying caught up on that, 11 so...

MR. TODD ALLRED: Really?

MS. MELISSA MCBRIDE: You should not be seeing that big backlog that you've been experiencing over the last couple of years.

With that, the last quarter - let me make sure I have 16 my right notes here - they processed 137 new plumbing 17 18 contractor applications; they renewed -- since we're just 19 coming up on the first renewal cycles, 101 plumbing contractors were renewed; 289 exams were taken. 142 of 20 21 those passed, with 147 failed. We don't have it drilled 22 down as far as reasoning. We just have that high-level 23 number right now. And we have 140 -- I'm sorry, 421 new 24 trainees since the last quarter.

25

And on the affidavits since last quarter, let's see, we



1 had a total of 1,085 affidavits submitted. And of that, 91 2 of those were completely denied for either being too old to accept affidavit or their certificate had lapsed during that 3 time frame. Other than that, there was 102 of those 4 applications -- or affidavits were not accepted on original 5 6 submittal, either the affidavit wasn't notarized or the 7 dates weren't filled out, it was altered, there was some 8 reason that they couldn't be accepted on first submittal. But of those 102, we're just waiting for them to be 9 10 resubmitted. And as long as that reason for denial is 11 corrected, they will be submitted and those hours will be 12 granted. 13 And so, overall, there was an 8 percent denial rate of 14 all the affidavits submitted that could not be accepted.

15

MR. TODD ALLRED: That was last quarter?

MS. MELISSA MCBRIDE: Yes. Even broke it down
into hours. Total hours approved: 957,054 hours were
approved.

So that's kind of what's going on in the program right now. Hopefully -- hopefully, you've been -- paperwork has been getting processed quickly. Whether or not it's accepted is one thing. But those letters are going out to the trainees. And I know I do get quite a bit of emails from the plumbing contractor company wondering what's happened. Happy to answer those emails and questions, but





1	the notification does go directly to the trainee's address
2	of record.
3	MR. TODD ALLRED: Is that in rule?
4	MS. MELISSA MCBRIDE: That it goes to the
5	trainee's address?
6	MR. TODD ALLRED: Yeah.
7	MS. MELISSA MCBRIDE: No. It's just because of
8	their certification, so the communication goes with them.
9	And it's also with the way the system is set up, it's
10	their record, their certification, so it's all addressed to
11	their address.
12	MR. TODD ALLRED: Okay.
13	MS. MELISSA MCBRIDE: That's all. That's all
14	we've been doing the last quarter.
15	MR. TODD ALLRED: Are you done with that?
16	MS. MELISSA MCBRIDE: Yes.
17	MR. TODD ALLRED: That's good stuff. Thank you,
18	Melissa.
19	So we're all caught up, and the industry can have an
20	expectation that when they contact Labor & Industries in the
21	plumbing department, that they can get somebody, get some
22	attention and get things resolved.
23	MS. MELISSA MCBRIDE: May I?
24	Yes, you can have that expectation; however, I do want
25	to clarify there are three, and, you know, they go to lunch, Page 12

1	they get sick. And so they take phone calls. It's not
2	uncommon that three are on the phone or maybe two are on the
3	phone and one is in the bathroom. So you might not get
4	through in the first ring, but you will get that call back
5	in the event that they are not all three readily available.
6	But they are there answering calls, taking care of you.
7	MR. TODD ALLRED: Very good. Very good. That's
8	excellent.
9	We may get some we may get a message out to the
10	industry and let them know that Labor & Industries has
11	reported that they're caught up. Different aspects of the
12	industry can let membership their people know that that's
13	the case, and we'll see if you get flooded again.
14	All right. Very good. Is that all you have for us?
15	MS. MELISSA MCBRIDE: Yes.
16	MR. TODD ALLRED: Are there any questions, any
17	additional input from anybody on the Board?
18	MR. BRAD MOORE: Good job.
19	MR. TODD ALLRED: Okay. Thank you. Thank you,
20	Melissa.
21	MS. MELISSA MCBRIDE: Yes.

7	compared to 2023.
8	So the PLO1, the journey-level, in 2020 there was
9	4,291. As of the last week, there's 4,388. So in the last
10	two years, there's been a 2 percent increase in
11	journey-level plumbers.
12	For the residential specialty, that went from 1,053 in
13	2020 to 1,201 in 2023, with a 14 percent increase.
14	For pump and irrigation, that actually went down
15	2 percent. There was 293 pump and irrigation, and now
16	there's 231.
17	And the last being the residential service. Obviously
18	that wasn't really a category; so it went from zero in 2020
19	and we now have 24.
20	MR. TODD ALLRED: And when did you pull these
21	numbers in 2023?
22	MS. MELISSA MCBRIDE: Last week. It was as of
23	last week.
24	MR. TODD ALLRED: Okay.
25	MS. MELISSA MCBRIDE: It was, like, Wednesday or

1	Thursday of last week.
2	MR. TODD ALLRED: July?
3	MS. MELISSA MCBRIDE: Yes, yes.

16	rusty, and so And then, yeah, we're just making by with
17	what we've got, so There's a whole bunch of trainees, I
18	know, coming up, but, yeah, just the way it works.

21	certified numbers for Melissa?

24	MS. MELISSA MCBRIDE: Actually, I forgot to give

1 MR. TODD ALLRED: Oh, yeah. Let's get that one in there. 2 MS. MELISSA MCBRIDE: 3 Sorry. For the trainees, which I left out, there was 421 new 4 trainees. And I don't have -- that was as of the guarter. 5 6 420 new ones as of last quarter. 7 Sorry, I forgot to mention that one. MR. TODD ALLRED: But we don't know how many we 8 9 had --10 MS. MELISSA MCBRIDE: No. I'll have her pull 11 that --12 MR. TODD ALLRED: -- in total? 13 MS. MELISSA MCBRIDE: -- but I did not get that 14 number. 15 Do you want that in general, or for your work sessions, 16 or both? 17 MR. TODD ALLRED: It would be good to have both, 18 yeah. 19 MS. MELISSA MCBRIDE: Okay. 20 MR. TODD ALLRED: Thank you, Melissa. 21 Okay. We're going to move on to the subgroup report. 22 If you guys recall at the last -- at the last 23 quarterlies meeting, we were mandated per RCW 18.106 to 24 convene a subgroup to evaluate the ratio changes that we had 25 on sunset. And so we convened that subgroup. We had our Page 16 meetings, and I handed out the -- this paper that went
 around, and on the back page is the results.

And so I'm looking for a motion from the Board here 3 The process is this: That if we approve this 4 today. language from the Board here, we're going to give this to 5 6 Mr. Blohowiak here to take to -- per the RCW, to take to 7 Chairs of the labor committees and Senate and House, making the recommendation that we keep ratios as is, on a 3-to-1 on 8 PLO3 -- or PLO2, PLO2 and -- 2, 3, and 4, I think is what it 9 10 is.

11 So we want to keep the ratios the same for another 12 cycle and then we'll evaluate. There's some other things 13 that are in the works to see if we get our industry manned a 14 little bit better. I don't know if I'm really at liberty to 15 say what those things are at this point because they are 16 still in the works, but may -- may get a bunch of our 17 trainees certified.

So what we want to do is get -- and once we have that -- once Mr. Blohowiak delivers that to them by December -he has until December 1st to get it to them, then the industry can then go and talk to legislators and try to get a bill passed -- get this bill passed in senate session to make sure we keep our ratios the same.

I think it's clear from the stakeholders' leadership group amongst the industry. If anybody disagrees, I'll



listen to anything anybody has to say about it, but I think
 we still have a seriously undermanned industry. And so
 that's our goal, is to keep the ratios like this to ensure
 that we can safely man our industry, take care of the public
 health.

6 So here is the -- the process was that the group of eight people met. So it was four people from the PHCC -7 plumbing, heating, and cooling contractors of Washington -8 9 we had three -- three folks from the Washington State 10 Association of Plumbers and Pipefitters, and we had one 11 representative from the Mechanical Contractors Association of Western Washington. And we sat down. 12 We had a 13 discussion. The meeting went a little longer than I 14 anticipated because I thought it was going to be much 15 quicker. But, anyway, here is the language that we're 16 proposing:

Due to the impact of the global pandemic, after the changes from Senate Bill 6170 were adopted, the Plumbing Advisory Board subgroup, pursuant to RCW 18.106.070, has concluded unanimously that the ratio change for residential plumbing of 3-to-1 needs to remain in existence for another (1) year.

This is the resolution coming out of the subgroup. And the reason that it's only one year is because the RCW states that we have to do this again in 2025, after the 2025



1 session, and then it moves into a three-year cycle for the 2 sunset. (Consulting with Mr. Blohowiak.) 3 Excuse me. After the 2024 session. Correction. 4 Thank 5 you. 6 See, you bring value. Awesome. Love it. Anyway, I would entertain a motion to accept this 7 language or any questions. Well, we can have questions 8 9 after a motion. 10 MR. ANTONIO CRUZ: So moved. 11 Thank you, Antonio. MR. TODD ALLRED: 12 MR. SCOTT FOWLER: Second. 13 MR. TODD ALLRED: Second. Thank you, Scott. 14 All right. Any discussion? 15 MR. SCOTT FOWLER: So it says here for just the Did you want to include the other ones too, the O3s 16 02s. and the O4s, or is it just about residential plumbing? 25	think the O3, O3As was written that way.

Okay. Mr. Scheuermann for our IAPMO update. MR. JED SCHEUERMANN: Thank you, sir. Jed Scheuermann with the IAPMO.

Some good things are happening. A lot of -- some of
this will be review from the last time I spoke with you.
Our conference reminder, that it is the 24th through the
28th of September in San Antonio.

And for those of you who don't know, our conference
this year is actually co-located. There's actually going to
be three organizations working together on this conference.
It will be IAPMO; it will be ARCSA, the American Rainwater
Catchment Systems Association; and ASSE, the American
Society of Sanitary Engineering.

14 So folks going to this conference actually get a lot of 15 opportunities for some very broad education. We've obviously got the code-type stuff from IAPMO; we've got 16 17 backflow prevention and sanitary engineering stuff from 18 ASSE; and then ARCSA, rainwater catchment, that's becoming 19 an increasingly big thing as we look at water stress in different parts of the country, particularly in the west and 20 21 in the south. So rainwater catchment is rising to the fore 22 as something that's becoming much more common and popular.

Our keynote speaker this year is going to be George
McGraw from Dig Deep. Dig Deep is a charitable organization
that believes that access to potable water is a basic human



right that all people should have, and their specific
 emphasis is to deal with 4 million Americans that do not
 have access to potable water today.

On the chapter side, last week we went up in Sequim. Thanks to Antonio and Brad and Ed Holmes and several others who, over the years, have been working hard together with a lot of folks up there and myself. And so last week we had 19 people at the chapter meeting up there, and there's some real good buzz and energy for the newest chapter of IAPMO.

Jason Switzer, back there, is going to get the
Rainier-Olympic chapter reinvigorated again. And I look
forward to helping you with that.

13 A couple weeks ago I met at Perry Tech with the 14 plumbing program there, and met the apprentices there and 15 the instructors there, and we have high hopes to get 16 something going in the Wenatchee/Yakima/Chelan-type area for 17 an IAPMO chapter over there as well.

And on the foundation side, our IWish Foundation from IAPMO has wrapped up a couple of projects lately. We did a project at Bacone College in Oklahoma, which is the Creek Nation, where we built a laundry at one of their universities.

A couple of weeks ago we got back from Alabama. We did
seven more homes where we improved the sanitation systems
and installed high-efficiency plumbing fixtures to reduce



1	the amount of sewage created by those homes.
2	And in two weeks, we're headed back down to the
3	Navaho Reservation to pilot some projects there on the
4	sanitation side with Indian Health Services and Navaho EPA.
5	And that is my report.
6	MR. TODD ALLRED: Thank you, Jed. That's good
7	work with IAPMO doing all those things with the
8	IWish Foundation there.
9	And I just have one question for you. Why are you
10	choosing to go to the Navaho Nation in the middle of August?
11	It's kind of a joke.


