The letters of interests will then go to the Director for consideration. The seats on the Board are for a 3 year term and as of yet the only requirements for this position is to attend the quarterly Board meetings. The positions with terms that have ended include: 1 Journey Level Plumber, 1 Specialty Plumber, 1 Plumbing Business Contractor, and 1 Public Member. If no letters of interest are submitted for any of the available seats, the current occupants will retain the position until filled by another.
