#### **Plumber Infractions**

Bruce stated the fourth quarter of 2021 there were 160 infractions written for \$54,200.00. The first quarter of 2022 there were 205infractions written for \$76,200.00 and for the second quarter of 2022 there were 240 infractions written for \$92,600.00.

## **IAPMO Update**

Jed Scheuermann stated IAPMO's annual conference in Charlotte, NC will be September 11<sup>th</sup> through September 15<sup>th</sup>.

The 2024 Codes is under development, check the IAPMO website to participate/learn more. The website is also a good place to go for knowledge regarding plumbing and answers to any questions.

#### **New Business**

A representative of the Department of Health was attending via ZOOM.

Guest Matthew Defeo discussed differences between Washington State and New York State
requirements to gain a Plumber Certification. Bruce explained Washington's requirements and Ed
explained that as Washington is not an apprenticeship state the hours earned towards a
certification must be verified. To change this would require changes to be made through
legislation.

Discussion followed

• Todd introduced discussion on Plumbing TAG Recommendation for Air Admittance Vents (AAVs) in the Code. Discussion followed regarding how these vents pose a threat to the public health and safety.

Todd made motion to advise Labor and Industries to support the decision of the Plumbing TAG to not approve the proposal 21-GPZ-057. Motion was second and approved.

Melissa stated that the motion would be given to LNI's legislation office for direction and will keep the Board updated on what LNI could or could not do.

Discussion followed

• Representative of Three Brothers Plumbing brought up concerns on processing time for Plumbing Contractor applications and for affidavits of experience.

Melissa explained the delay occurred due to limited staff and an overwhelming amount of applications. If the application is incorrect this could also delay processing.

Bruce explained that affidavits for the previous year's work should be turned in at the time of renewal.

Discussion followed

• Guest wanted to open up conversation about Drain Cleaning being under Plumbing and how this is negatively impacting the industry. Chair stated more facts and data will need to be gathered before a proper discussion could be had and that any changes regarding this would need to be done through legislation.

## **Old Business**

No old business was discussed
