Approved Minutes

Meeting Minutes of April 20, 2021 meeting minutes approved

Rules Update/Discussion - Bruce

Bruce gave update on Rules and stated 1^{st} and 2^{nd} phases were finished and the 3^{rd} phase was to start soon.

Plumbing Contractor Laws

Chairman opened discussion up with question and answer session for Bruce to answer.

Q: Can a contractor keep their existing license and license number? Do you need a separate bond? A: If you have an existing General Contractor license you can keep the General but you will need to have a separate Plumbing Contractor. You will have a new license number for the Plumbing Contractor, you will also need a separate \$6000 Bond for the Plumbing Contractor.

Q: Do you need to close or use two LNI accounts?

A: You can use your existing UBI and industrial insurance.

Q: Can you use the same Bond?

A: No, you will need a separate \$6000 Continuous Plumbing Contractor Surety Bond for your Plumbing Contractor.

Q: Can you use the same Certificate of Insurance?

A: No, you will need a separate Certificate of Insurance.

Q: What do contractors need to have on their truckers for advertising?

A: You do not have to have your business information listed on your work vehicles in current Plumbing Law.

Q: Can you use your UBI number from your General Contractor for your Plumbing Contractor? A: Yes, you can use the same UBI number.

Q: What all is needed for this change?

A: You will need to complete the Plumbing Contractor Application, the Designated Plumber Application, attain and send copies of you Continuous Plumbing Contractor Surety Bond, and provide copies of your Certificate of Liability Insurance (\$250,000 combined per occurrence. amount) on which L&I must be the certificate holder with the PO Box listed as 44470.

Q: The grace period is until 9/1/2021 before tickets will be written?

A: You will need to maintain an active Construction Contractor (General or Plumbing Specialty) and have submitted your application for the Plumbing Contractor by 9/1/2021 to be in good standing.

PSI Testing

Bruce informed on status with PSI testing. Plumber Examinations were moved to a 3rd party testing facility in April. There are updates continuing that will help to sort out the kinks. Currently working to go to an automated system with PSI.

PSI normally tests 6 days a week however COVID19 has impacted their number allowance in their buildings and some locations are in higher demand than others.

PSI has multiple testing locations around the state and some available in other states. If an applicant is looking to test outside of Washington they will have to contact PSI to see if their state has a testing facility available.

Applicants will know immediately after they finish the exam if they have passed or failed.

Plumber Infractions

Bruce stated for the first quarter of 2021, there were 101 infractions written for \$26,600.00. For the second quarter of 2021, there were 113 infractions written for \$34,003.00.

Infraction amounts start at \$100 for individuals and can go up to \$5000. Individuals can also receive warnings from an inspector.

Infraction amounts for contractors start at \$500 and can go up to \$5000. Contractors do not get warnings.
