The committee decided to have a focused discussion on the purpose of the committee at the April 2023 meeting, and agreed the Chair and Vice-Chair would work with L&I to prepare for the discussion.





# **Updates**

### Legislative (Karen Jost)

- HB 1197 / SB 5310: Defining attending provider and clarifying other provider functions for workers' compensation claims, and adding psychologists as attending providers for mental health only claims
- **HSB 5454:** Concerning industrial insurance coverage for posttraumatic stress disorders affecting registered nurses
- **HB 1068 / SB 5212**: Concerning injured workers' rights during compelled medical examinations
- SB 5335: Developing the Washington Health Trust

#### **ProviderOne (Karen Jost)**

Karen Jost gave an update on the migration of provider credentialing data to ProviderOne. Currently, new L&I-only providers are required to apply in ProviderOne. Additional waves of providers will be migrated to ProviderOne through June 2023. The program will continue to update providers through email, letters, and the website.

#### Long COVID (Ji Young Nam)

Ji Young Nam reviewed terms and definitions, prevalence and known risk factors for long COVID along with new statistical data and barriers for returning to work.

#### **Operational Health Dashboard (Mike Ratko)**

Mike Ratko gave an update on the Operational Health Dashboard, the five metrics that are being monitored and the overall levels of productivity that have remained consistently high since the start of the pandemic.

# Provider Recognition Program (Noha Gindy & Athena Hightower)

The Provider Recognition Program (PRP) pilot has had fewer provider applications than had been hoped. Possible next steps with the program were reviewed in detail and feedback was
