### **L&I Reopening (Kim Wallace)**

Morgan provided an update on the COHE procurement. Plan is to have new contracts in effect on July 1, 2022. The team is currently in the process of evaluating the eight proposals that were received from the solicitation.

### **Provider Recognition Program Pilot (Jeana Weekley)**

Planning to start taking applications on July 1<sup>st</sup>. Jeana reminded the committee that this is a pilot. We will apply learning from the pilot to finalize program design and processes before launching the full program. We will include 100 providers in the pilot. There will be an interactive training module that can be accessed online.

### **Healthy Worker Strategic Planning (Diana Drylie)**

Diana led the committee through a process to gather ideas for strategic initiatives that fit under the major Healthy Worker goals.

### **COHE-Themes from Key Informant Interview (Jason Fodeman & Morgan Wear)**

Jason shared the methodology, results, and recommendations that emerged from the Key Informant Interviews. The interviews targeted six COHE audiences: clinical leadership, executive level leadership, operational leadership, health services coordinators, future sponsors & business and labor.
