Background

The Industrial Insurance Chiropractic Advisory Committee (IICAC) was formed by the Washington State Legislature in 2007. [Chapter 296-20WAC](http://app.leg.wa.gov/Chapter/296-20WAC) (app.leg.wa.gov) authorizes the IICAC to:

“Advise the department with respect to the provision of safe, effective, and cost-effective health care for injured workers, including but not limited to, policy development regarding chiropractic care for injured workers, the development of practice guidelines and coverage criteria, review of coverage decisions and technology assessments, review of chiropractic programs, and review of rules pertaining to health care issues.”
