Opening Remarks	<p>Craig Blackwood, L&I Deputy Assistant Director, Division of Occupational Safety and Health, BLAC235@Lni.wa.gov</p> <p>Anne Soiza was unable to attend today's meeting, as she is in Washington DC chairing the NACOSH meeting, and Craig is standing in for Anne. Craig welcomed everyone and around the room introductions were made.</p>
2020 Legislative Session	<p>Tammy Fellin, L&I Legislative Director, FELU235@Lni.wa.gov</p> <p>The 2020 legislative session begins January 13th and is a short 60-day session. Tammy said she believes the transportation budget will take center stage due to the passing of Initiative 976 (\$30 car tabs). L&I is not intending to have any policy proposals; worked on 12 or so, but not ready; talked about other ways to approach. L&I will ask for a supplemental budget request of just over \$5 million including bills that were passed last session that did not come with funding. Requesting \$1.5 million to increase the number of elevator inspectors due to an audit finding that revealed there is not enough staff to meet statutory requirements. We have done classification/compensation studies for elevator inspector positions, which did raise the salary for those positions, but recruitment and retention issues remain. Discussion, questions and answers about the elevator program followed.</p>

<p>Rules Update</p>	<p>Alan Lundeen, Senior Manager for DOSH Standards, Technical and Laboratory Services LUND235@Lni.wa.gov</p> <p>Rulemaking Summary handout was provided that lists all of DOSH’s rulemaking activity currently in progress.</p> <p>Two rules will be coming into effect soon:</p> <ul style="list-style-type: none"> • Recordkeeping and Reporting: Effective 1-1-2020. This has been a four year rulemaking project; will be in line with OSHA. • Pesticides/Worker Protection Safety (WPS): Effective in February 2020 <p>Two rule projects on the summary list are near to being filed as rules:</p> <ul style="list-style-type: none"> • Walking Working Surfaces – bring information up-to-date with OSHA; effective date Summer 2020 • Unified Fall Protection – have been working on this quite a while; talks continue with OSHA regarding under 10 foot exemptions. <p>DOSH plans to hold stakeholder meetings for both of these rules at the same time; no dates have been set; locations will likely be Spokane, Yakima, Tukwila, and Tumwater.</p>

Public hearings to take place in February 2020. • Asbestos Removal and Encapsulation – No comments were received from stakeholders; will adopt 1/21/2020 <p>Alan and Craig mentioned there were three handouts available at today’s meeting:</p> <ol style="list-style-type: none"> 1. DOSH Hazard Alert, issued September 2019, titled <i>Fall Protection Lifelines Cut by Exposed Edges</i>, which provides information for employers and workers who rely on personal fall arrest systems; has received national attention 2. Information regarding Process Safety Management (PSM) rulemaking timeline – a one page document providing an update on the timeline for the next steps relating to the ongoing rules development and stakeholder engagement efforts relating to Process Safety Management 3. DOSH Directive 8.55, titled <i>Tower Crane Erection and Dismantling Violations</i>, issued 11/4/2019. SHIP Update	<p>Jenifer Jellison, SHIP Program Manager, JELJ235@Lni.wa.gov</p> <p>Jenifer shared that the SHIP grant cycle for the safety and health grant proposals will close next Monday. The grant cycle for the Return to Work grant proposals will remain open until further notice; so far only one Return to Work grant proposal has been received.</p> <p>Jenifer introduced Laura Pierce from Washington Nonprofits. Laura provided information to the group on their completed grant project, which is a safety and health guide for nonprofit employers in Washington State, titled <i>Safety & Health in Nonprofits</i>. Laura talked about their experience with SHIP and others while completing their project and how this customized guide has positively impacted the many nonprofit employers in our state.
