




As discussed at the Construction Advisory Committee meeting last week we are in the process of developing a newsletter for the construction industry.





Trenching Excavation - Tukwila, Kennewick, Spokane and virtual

A training program improves consistency and is the most efficient way to educate staff.

Rule Updates Rulemaking Activity at L&I

Cranes – the department filed the CR 102 in March, plan to file the CR103 in August with an effective date in September of 2025. Public hearings were held in May.

Tower Cranes – Filed CR 101 in January, stakeholder meetings held in May 2025, filing the CR 102 in August

ERGO - no updates, time frame TBD

FRMA – Effective date July 1st 2025

Sanitary Conditions - Effective date July 1st 2025

Trenching - promulgate a trenching safety plan requirement.

The department had smaller stakeholder groups, now have moved to the larger stakeholder meeting. August with virtual August 20^{th}

Other rules - Indoor heat, lead, infectious disease, Covid-19 log (due to staffing and FED OSHA's rule making, probably on hold for the next 4 years)

Labor and Industries highlights:

Outreach

Development of <u>a</u> industry specific Accident Prevention Program, that meets the requirements for VPP and START.

Goal is to have a fillable/editable document that would address the program requirements of an Accident Prevention Program

Standards

Effort is underway to remove the <u>PDF's</u> on the L&I website and access to the rules would be available only on the legislative website. This effort is to reduce inconsistencies between the L&I website and the legislative site. The legislative website is the law, where L&I's website though it copies from the legislative site WAC's, has tables and outreach as well as some inaccuracies. In order to correct it incurs much staffing time to correct and update.

Certification Programs

Fire resistant material is accepting applications from training providers to have their programs reviewed and approve so the provider can train applicators for certification from the state. July 1st 2026, applicators will need to have gone through the training and be certified. Fire-Resistant Materials Applicator Rulemaking

Special Interest

There have been third part flagging cards issued to workers that are not State issued from an approved training provider by the Traffic Control Oversight Committee (TCOC). Workers controlling traffic in construction must have a state issued flagging card (see example below). In the month of July, there were approx. 11 hospitalizations that were investigated in WA State. The most were in region 2 (King County area) with. Causes:

- Fall from elevation 4
- Struck by 2
 Outdoor heat 2

- Amputation /finger working with wood 4
 - Impalement (nail gun) 1
- Caught between 1

Smallest employer - 1 employee, largest employer 802 employees. 11 employers considered small (20 or less)

5 workers as of June 27th have lost their lives in a workplace incident

DOSH Rules Updates

Thomas West

Safety & Health Rules

- Cranes, Rigging, and Personnel Lifting Part L Update
 - OSHA alignment, implementing parts of 2SHB 2022, state-initiated changes to align with industry current practices, and other housekeeping updates
 - Became effective September 5, 2025
 - Presenting updates about the final rule at Governor's Industrial Safety and Health Conference September 24, 2025
 - Anticipate filing expedited rulemaking (CR-105) on September 30, 2025, to fix an oversight in the definition of *qualified evaluator (employer)*, WAC 296-155-52902(144).
- Tower Crane Permitting
 - Establishes a permit program for tower cranes per 2SHB 2022.
 - CR-102 filed on August 19. Holding public hearings 9/23 (Spokane), 9/29 (Tukwila), and 9/30 (Virtual)
 - Anticipate filing CR-103 in November, with an early December effective date

Safety & Health Rules

- Trenching Excavation, Chapter 296-155 WAC, Part N
 - Due to a number of tragic incidents, L&I is updating the trenching and excavation rule to ensure workers are trained and can proceed safely with any trench excavation BEFORE they dig
 - Held stakeholder meetings in July and August.
 - Reviewing stakeholder feedback and will make updates to the preliminary draft and draft work plan prior to filing a CR-102
 - Anticipate filing CR-102 later this fall or in the winter and holding public hearings next year

Steven Heist

- Engrossed House Bill (EHB 2266) Codified under RCW 49.17.530
- Law became effective June 6, 2024
 - Access to adequate portable toilet/restroom
 - Minimum size, prevent inadvertent entry, adequate time to accommodate for multiple layers, adequate convenient supply of menstrual hygiene products – provided by employer at no cost to employee

- Reasonable accommodations to express milk after child's birth
 - Flexible schedule, breaks
 - Private dedicated space, not a bathroom, lockable and free from intrusion
 - Convenient water source to wash supplies and hands

- Completed rulemaking in WAC 296-155-140(6)
 - Effective July 1, 2025
 - Resources from L&I and industry
 - Informational website: <u>Sanitary Conditions for Construction Workers</u>
 - L&I partnering with relevant labor organizations, and the Office of Minority and Women's Business Enterprises, to perform outreach to construction employers
 - To date, no complaints or inspections generated by Compliance




