

## Employers will play an important role in controlling the spread of COVID-19

Employers have asked for guidance on what to do to respond to the spread of COVID-19 disease. Employers should start taking steps now, and should be using all resources necessary to prepare for and respond to the outbreak.

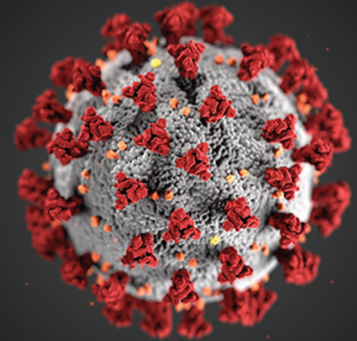
In addition to normal hazard-prevention strategies, like engineering controls or personal protective equipment for specific hazards, all employers should now develop and implement infectious disease safety strategies, including the following steps:

- Implement business/worksites specific social distancing (including worker and customer interactions).
- Post educational posters for employees.
- Encourage sick employees to stay or go home.
- Promote frequent and thorough handwashing with adequate supplies of soap and running water, and when not readily available, alcohol based hand rubs of at least 60 percent alcohol.
- Encourage respiratory etiquette, including covering coughs and sneezes.
- Discourage the sharing of utensils, desks, phones, and work tools.
- Maintain regular housekeeping/disinfection practices.

### Social Distancing:

Social distancing can help control rapid escalation of the number of infections. Employers should implement business/worksites specific social distancing strategies to reduce the frequency, proximity, and duration of contact between people (both employees and customers) to help reduce the number of coronavirus exposures. This is particularly important in geographical areas of high disease transmission potential as identified by government leaders and local health departments.

Employers can gather ideas from employees about eliminating unnecessary physical contact with customers or fellow employees. Strongly consider elimination of in-person meetings that can be done electronically. Implement new company-wide greeting practices such as head nods or a wave or other non-touching gestures.
